

**The speculator: a case study of the dynamic programming equation of an infinite horizon stochastic problem**

We present an optimal control problem of a speculator maximizing the discounted profit from selling his stock of foreign currency. The dynamic programming equation has a unique solution complying with natural restrictions and show that this solution truly represents the value function of the problem. We discuss extensively the results in the context of other infinite horizon stochastic optimal control problems.
